

**GENERAL ASSISTANCE FACT SHEET (EFFECTIVE 10/1/2021)**

<b>WHO CAN GET GENERAL ASSISTANCE</b>	Santa Cruz County residents 18 years or older may qualify, depending on income, resources and other eligibility factors.
<b>LOAN PROGRAM</b>	General Assistance (GA) is a LOAN program. You will be required to apply for other types of available income as a condition of eligibility.
<b>ELIGIBILITY BASICS</b>	<p>Eligibility is determined by:</p> <ul style="list-style-type: none"> <li>• US Citizenship or lawful non-citizenship</li> <li>• Must Have CA ID</li> <li>• County residency</li> <li>• Household/living arrangement</li> <li>• Income &amp; Resources/Property</li> <li>• Student status</li> </ul>
<b>WHAT IS A HOUSEHOLD?</b>	<p>For General Assistance eligibility, a “household” is a family unit living together and sharing resources and expenses. All members of your household must apply for and be eligible in order for you to receive General Assistance.</p> <p>Homeless persons may also qualify for General Assistance.</p>
<b>INCOME</b>	<p>All income received is deducted dollar for dollar from your General Assistance benefit. The income limit depends on your living arrangement.</p> <p>Income includes all earnings, self-employment income, alimony, child support, social security, SSI/SSP, unemployment benefits, state disability, worker’s compensation, cash gifts, pre-paid credit cards (including but not limited to Visa, Master Card, American Express), loans, student financial aid and retirement income.</p>
<b>RESOURCES</b>	<p>To qualify for General Assistance, you must not exceed the following resource limits:</p> <ul style="list-style-type: none"> <li>• Cash or other liquid assets – no more than \$200 per single person or \$300 per household.</li> <li>• Vehicle – vehicle value cannot exceed \$4,650 after deducting any amount owed; cannot own more than one vehicle.</li> <li>• Property – may own a home in which you are living; the value cannot exceed \$25,000 after deducting any amount owed. The value of any other property will be considered a resource.</li> <li>• The value of other property (not including personal household property, heirlooms and tools required to work) cannot exceed \$100 per single person or \$200 per household.</li> </ul>
<b>COLLEGE STUDENTS</b>	College students who are able to work (not disabled) are not eligible for General Assistance.

## GENERAL ASSISTANCE FACT SHEET (EFFECTIVE 10/1/2021)

<b>WORK REQUIREMENTS</b>	If you are not disabled and are able to work, you will be required to attend a Job Search Workshop and look for employment. Before or after attending said workshop, you will be required to do 20 job searches. You must provide proof of your job search to your Benefit Representative on the 1 <sup>st</sup> and 15 <sup>th</sup> of each month. You must also accept any reasonable offer of employment.		
<b>DISABLED PERSONS</b>	If you are disabled, you will need to get a doctor's statement. Most disabled persons will be required to apply for SSI and must work in cooperation with County staff during the application and approval process for SSI.		
<b>HOW MUCH GENERAL ASSISTANCE WILL YOU GET?</b>	<p>Depending on your living arrangement and income:</p> <ul style="list-style-type: none"> <li>• Single person with no rent= \$398; with rent can be a maximum of \$638.</li> <li>• Two-person household with no rent= \$488; with rent can be a maximum of \$819.</li> </ul> <p><i>For those living in a licensed board and care home, residential facility or recovery house, a separate benefit schedule is used.</i></p>		
<b>HOW TO USE GENERAL ASSISTANCE BENEFITS</b>	<p>You will receive your cash benefits on a plastic EBT (Electronic Benefits Transfer) card. You may use this card at any participating retail store, bank or ATM.</p> <p>You may receive some General Assistance rent benefits as a check payable to you and your landlord. These benefits are designated only to pay rent. Written landlord verification is required.</p>		
<b>YOUR RIGHTS</b>	Whether you are eligible or not, you have the right to be treated with dignity, respect, and courtesy when you apply for General Assistance. The Human Services Department will not discriminate against anyone because of race, color, national origin, political affiliation, religion, age, sex, marital status, or condition of physical or mental disability. If you believe that you have not been treated equally, contact the Civil Rights Officer at (831) 454-4117.		
<b>INTERVIEW LANGUAGE</b>	Applicants may be interviewed in English, Spanish, American Sign Language, and others if necessary.		
<b>HOW TO APPLY</b>	<p><b>You may apply in person at either of our service centers.</b></p> <table style="width: 100%; border: none;"> <tr> <td style="width: 50%; vertical-align: top;"> <p><i>In Santa Cruz:</i> 1020B Emeline Avenue Santa Cruz, CA 95060 (831) 454-4165</p> </td> <td style="width: 50%; vertical-align: top;"> <p><i>In Watsonville:</i> 18 W. You may also designate a person familiar with your circumstances to apply as your representative.</p> <p>You will be given an appointment to meet with a Benefit Representative. The appointment will take 1-2 hours.
